1 This Act may be cited as the Drainage Act 1961.

- 8 The Ministry shall—
 - (a) be responsible for the maintenance and improvement of the drainage of all land;
 and
 - (b) carry out such works and issue such notices concerning drainage works for the maintenance and improvement of drainage.

- 9 The Permanent Secretary shall have the power to do all things necessary to carry out the functions conferred upon him or her under this Act and, in particular, shall have power—
 - (a) to maintain drainage works;
 - (b) to improve any drainage works;
 - (c) to construct new drainage works;
 - (d) [Repealed]
 - (e) to control livestock so as to prevent damage to drainage works;
 - (f) to enter any land at any time for the following purposes—
 - (i) to do all acts necessary to ascertain whether any drainage measures are necessary or desirable;
 - (ii) to construct, maintain and improve drainage works;
 - (iii) to inspect drainage works;
 - (iv) to ascertain whether maintenance or other measures notified by the Permanent Secretary have been or are being carried out;
 - (v) to survey and take levels of any land;
 - (vi) to dig and bore in and under the ground;
 - (vii) to clear, set out and mark the boundaries of any land in connection with drainage works;
 - (viii) to prevent or detect the commission of an act constituting an offence under section 21;
 - (ix) to secure the proper control of livestock where drainage works are undertaken,

provided that-

- (A) before entering any land within the curtilage of a dwelling house, the Permanent Secretary shall first inform the occupier of the Permanent Secretary's intention to do so; and
- (B) if any damage is caused when entering such land, compensation shall be paid as soon as practicable for such damage;
- (g) to delegate any function or power under this Act to any officer of the Ministry.

- 20 (1) The Permanent Secretary may issue a notice requiring the owner of any land to, at his or her own expense—
 - (a) lay, build, dig, construct, improve, maintain or alter any drain within his or her land (other than a public drain or part thereof) which the Permanent Secretary deems necessary in the interests of good drainage; and
 - (b) take such steps in regard to any tree or other vegetation on any land of his or hers adjacent to a public drain as may be necessary to ensure that no fruit, leaves, branches, tree trunk or other vegetation shall—
 - (i) impede the free flow of water in any public drain; or
 - (ii) interfere with or damage in any way drainage works appurtenant to such public drain.

- (2) Every such notice shall be deemed to have been served if a copy is—
 - (a) sent by registered post to the owner; or
 - (b) affixed to the property of the owner concerned.
- (3) In the case of a notice requiring the laying, building, digging, construction or improvement of a drain—
 - (a) an aggrieved owner may, within 14 days, appeal to the Minister; and
 - (b) the decision of the Minister shall be final.

- (4) Any such notice shall be a good and valid notice notwithstanding any provisions in any document of title relating to such land and compliance therewith shall not constitute a breach of any agreement, covenant or condition in any such document of title. - (5) If the owner fails to comply with any requirement of a notice served under subsection (2) within such time as the Permanent Secretary may require, being not less than 30 days from the date of service of the notice, the Permanent Secretary may undertake the work and the cost shall be a debt to the State and may be recovered in a court of competent jurisdiction.

- 21 Any person who, without the prior authority of the Permanent Secretary—
 - (a) interferes with any public drainage works or any part thereof;
 - (b) wilfully performs an act whereby the efficient operation of any drainage work or measure is impaired;
 - (c) maliciously damages any public drainage works or part thereof;
 - (d) obstructs or otherwise interferes with the free flow of any water in a public drain;
 - (e) leads any animal or suffers or permits any animal to stray upon the banks or side walls of any public drain;
- (f) constructs any watercourse which connects directly to a public drain, shall be guilty of an offence and shall be liable upon conviction to—

- (i) in the case of a natural person, a fine not exceeding \$25,000 or imprisonment for a term not exceeding 10 years or both; or
- (ii) in the case of a body corporate, a fine not exceeding \$100,000 and for a director, manager or officer in charge for the time being, a fine not exceeding \$25,000 or imprisonment for a term not exceeding 10 years or both.

24 For the purposes of this Part, "drainage board" means a drainage board existing under this Act immediately before 1 August 2018.

[DRA 25] Revocation of appointment of members of a drainage board

25 All appointments of members to a drainage board existing immediately before 1 August 2018 are revoked.

[DRA 26] Transfer of assets, interests, rights, privileges, liabilities and obligations

- **26** (1) All assets, interests, rights, privileges, liabilities and obligations of a drainage board are transferred to and vest in the State without conveyance, assignment or transfer.
- (2) Any right or liability vested in the State under subsection (1) may, on or after 1 August 2018, be enforced by or against the State in its own name and it is not necessary for the State to give notice to any person whose right or liability is affected by the vesting.

[DRA 27] Transfer of officers and servants

- **27** (1) All officers and servants appointed under this Act to a drainage board immediately before 1 August 2018 are transferred to the Ministry.
- (2) Until such time as the terms and conditions of the officers and servants transferred under subsection (1) are determined by the Ministry, the terms and conditions of such officers and servants continue to apply to every officer or servant transferred under subsection (1).

[DRA 28] Existing deed, bond, agreement, instrument or arrangement

28 All deeds, bonds, agreements, instruments and arrangements to which a drainage board is a party immediately before 1 August 2018 continue in force and are enforceable by or against the Ministry as if the Ministry had been a party to the deed, bond, agreement, instrument or arrangement.

29 Any action, arbitration, proceeding or cause of action existing under this Act immediately before 1 August 2018, is pending against or in favour of a drainage board, or to which the drainage board is a party, may be prosecuted and, without amendment to any writ, pleading or other document, continued and enforced against or in favour of the Ministry.
